### Note on interpretation:

Data is sourced from end-of-day incident reports from Site Management Support agencies, compiled by the Site Management Sector with technical support from IOM Needs and Population Monitoring (NPM).

Data cleaning and verification is done daily, and continues in the days after; cumulative numbers may therefore be slightly adjusted to reflect new verifications or reports received. The daily report reflects incidents reported during a 24 hour period. It includes incidents reported the previous day after 18:00; and incidents reported today, up to the 18:00 deadline. Any incident reports received outside of a 24hour timeframe are included in the following day's cumulative numbers, and are fully reflected on the online map.

All numbers are indicative, from rapid on-the-day assessment data collection to inform mobilization of first response.
