Weekly Report: On Israeli Human Rights Violations in the Occupied Palestinian Territory

Israeli Occupation Forces (IOF) Escalate Attacks against Palestinian Civilians and Property in the Occupied Palestinian Territory (OPT), Especially in the Gaza Strip

- 23 Palestinians, including one civilian, were killed by IOF in the Gaza Strip.
- 10 of the victims were extra-judicially executed by IOF.
- 8 of the victims were killed by IOF during an offensive on al-Musaddar village in the central Gaza Strip.
- 32 Palestinians were wounded by the IOF gunfire in the Gaza Strip, and 9 persons, including an American human rights defender, were wounded by IOF in the West Bank.
- IOF invaded al-Musaddar village in the central Gaza Strip
- IOF razed 133 donums of agricultural land.
- IOF partially destroyed 10 houses and arrested one Palestinian.
- IOF transformed a number of houses into military sites.
- IOF conducted 24 incursions into Palestinian communities in the West Bank.
- IOF arrested 87 Palestinian civilians, including a member of the Palestinian Legislative Council, in the West Bank.
- IOF have continued to impose a total siege on the OPT.
- IOF have isolated the Gaza Strip from the outside world and a humanitarian crisis has emerged.
- IOF prevented at least 150 Palestinian pilgrims to travel through Erez crossing.
- IOF troops positioned at checkpoints in the West Bank arrested 3 Palestinian civilians.
- IOF have continued settlement activities in the West Bank and Israeli settlers have continued to attacks Palestinian civilians and property.
- IOF demolished a house in Jerusalem
- Israeli settlers attacked a Palestinian farmer in Nablus.

Summary

Israeli violations of international law and humanitarian law continued in the OPT during the reporting period

– 26 December 2007):

Shooting: During the reporting period, IOF killed 23 Palestinians. Ten of the victims were extra-judicially executed in 3 IOF air strikes in less than 9 hours at the eve of the Eid al-Adha. The victims were all members the al-Quds Brigades (the armed wing of Islamic Jihad). Additionally, 10 civilian bystanders were wounded.

On 20 December 2007, IOF killed 8 members of the Palestinian resistance during an incursion into al-Musado village in the central Gaza Strip. Additionally, 21 Palestinians, including a woman, 2 children and 2 journalist were wounded.

On 18 December 2007, an IOF air strike killed 2 police officers in Rafah. On 21 December 2007, IOF killed a member of the Palestinian resistance in 'Abasan village, east of Khan Yunis. On 24 December 2007, IOF killed 2 members of the Palestinian resistance in al-Boreij refugee camp in the central Gaza Strip.

On 23 December 2007, a Palestinian civilian was wounded by a gunshot fired by IOF, when he was on his lar in the east of Deir al-Balah town in the central Gaza Strip.

In the West Bank, 13 Palestinian civilians and an American human rights defender were wounded by IOF gunfire.

On 14 and 21 December 2007, 9 Palestinian civilians and an American human rights defender were wounded when IOF used force to disperse peaceful demonstrations in Bal'ein village, west of Ramallah, organized in protest to the construction of the Annexation Wall. On 14 December 2007, a Palestinian civilian was wounded by IOF gunfire near the Annexation Wall to the south of Hebron. On 23 December 2007, IOF troops positioned at a checkpoint near Beit Ummar village, north of Hebron, wounded and arrested a Palestinian civilian. On 24 December 2007, 2 Palestinian children were wounded by IOF gunfire in 'Azzoun village, east of Qalqilya.

Incursions: During the reporting period, IOF conducted at least 24 military incursions into Palestinian communities in the West Bank. During those incursions, IOF arrested 87 Palestinian civilians, including 2 children, a member of the Palestinian Legislative Council, 2 members of the municipal council of Nablus and university professors. Thus, the number of Palestinians arrested by IOF in the West Bank since the beginning this year has mounted to 2,640.

In the Gaza Strip, on 20 December 2007, the second day of the Eid al-Adha, IOF moved into al-Musaddar village in the central Gaza Strip. During this incursion, IOF killed 8 Palestinians and wounded 21 others. The also razed 73 donums of agricultural land and partially destroyed 10 houses. Additionally, IOF arrested a Palestinian civilian. On 21 December 2007, an IOF infantry unit moved into 'Abasan village, east of Khan Yunis. During this incursion, IOF troops killed a member of the Palestinian resistance.

Restrictions on Movement: IOF have continued to impose a tightened siege on the OPT and imposed severe restrictions on the movement of Palestinian civilians in the Gaza Strip and the West Bank, including occupied East Jerusalem.

Gaza Strip

IOF have continued to close all border crossings of the Gaza Strip for nearly 18 months. The total siege imposed by IOF on the Gaza Strip has left disastrous impacts on the humanitarian situation and has violated the economic social rights of the Palestinian civilian population, particularly the rights to appropriate living conditions, health and education. It has also paralyzed most economic sectors. Furthermore, severe restrictions have been imposed on the movement of the Palestinian civilian population. Moreover, the siege imposed on the Gaza St has severely impacted the flow of food, medical supplies and other necessities such as fuel, construction materials and raw materials for various economic sectors. IOF have further tightened the siege imposed on the Gaza Strip since Hamas' takeover of the Gaza Strip, and the living and economic conditions of Palestinian civilians have further deteriorated. On 19 September 2007, the Israeli government declared the Gaza Strip as hostile entity" and accordingly measures of collective punishment against Gaza escalated. Since that time, IO have limited the goods exported to the Gaza Strip to only 9 basic materials. As a consequence, local markets rout of many goods, which caused a sharp increase in prices, which mounted to 500% for some goods. IOF has banned the flow of some medicines, furniture, electrical appliances and cigarettes into the Gaza Strip, and have decreased the amounts of some goods allowed into the Gaza Strip, such as fruits, milk and some dairy produc

West Bank

IOF have continued to impose severe restrictions on the movement of Palestinian civilians. Thousands of Palestinian civilians from the West Bank and the Gaza Strip have been denied access to Jerusalem. IOF have established many checkpoints around and inside the city. Restrictions of the movement of Palestinian civilian often escalate on Fridays to prevent them from praying at the al-Aqsa Mosque. IOF often violently beat Palestinian civilians who attempt to bypass checkpoints and enter the city. IOF have also tightened the siege imposed on Palestinian communities in the West Bank. IOF positioned at various checkpoints in the West Bank continued to impose severe restrictions on the movement of Palestinian civilians. IOF also erected more checkpoints on the main roads and intersections in the West Bank. During the reporting period, IOF troops positioned at checkpoints and border crossings in the West Bank arrested at least 3 Palestinian civilians.

Settlement Activities: IOF have continued settlement activities and Israeli settlers living in the OPT in violat of international humanitarian law have continued to attack Palestinian civilians and property. During the reporting period, IOF demolished a Palestinian house in Wad al-Jouz neighborhood in East Jerusalem. A num of Israeli settlers also attacked a Palestinian farmer in Til village, southwest of Nablus, injuring him.

- At approximately 01:30, IOF moved into Qabatya village, southeast of Jenin. They raided and searched number of houses, but no arrests were reported.
- At approximately 20:00, an IOF undercover unit moved into Jenin refugee camp in the northern West Bank, traveling in a civilian vehicle with a Palestinian registration plate. The vehicle stopped neat a coffee shop belonging to Hussein Faisal Abu Sirriya, and IOF troops raided the coffee shop. They arrested 12 Palestinian civilians:

Friday, 14 December 2007

• At approximately 01:30, IOF moved into Jenin. They raided and searched a number of houses, but no arrests were reported.

- At approximately 01:30, IOF moved into Battir village, west of Bethlehem. They raided and searched a number of houses and arrested 5 Palestinian civilians:

- At approximately 01:00, IOF moved into Nahalin village, west of Bethlehem. They raided and searched number of houses and arrested 2 Palestinian civilians:
 - 1. Lu'ai Mohammed Ghayaza, 22; and
 - 2. Rezeq Mohammed Ghayaza, 28.
- At approximately 01:30, IOF moved into al-Fara'a refugee camp, south of Tubas. They rainded and searched a number of houses and arrested 2 Palestinian civilians:
 - 1. 'Azzam 'Ali Jawabra, 44; and
 - 2. Eyad Mohammed Sarhan, 37.

Tuesday, 18 December 2007

- At approximately 01:00, IOF moved into al-Bassa neighborhood in the southwest of Hebron. They raid and searched a house belonging to the family of Murad Bader Shaheen, 30, director of the office of member of the Palestinian Legislative Councils representing Hamas, and arrested him.
- At approximately 10:45, an IOF aircraft fired a missile at a police station of the dismissed Palestinian government in Musabbeh neighborhood in the north of Rafah. Two police officers were killed:
 - 1. Hani Najeh Barhoum, 21; and
 - 2. Mohammed Khaled al-Shareef, 20.

Thursday, 20 December 2007

• IOF Offensive on al-Musaddar Village in the Central Gaza Strip

In the early morning, IOF moved into al-Musaddar village in the central Gaza Strip. They raided a number houses and transformed them into military sites. During this incursion, which continued until the evening, IOF killed 8 members of the Palestinian resistance and wounded 21 Palestinians, mostly civilians, includin journalists. IOF also destroyed 10 houses partially, razed 73 donums of agricultural land and arrested a Palestinian civilian.

According to investigations conducted by PCHR, at approximately 00:30, an IOF infantry unit moved near 1,000 meters into al-Musaddar village in the central Gaza Strip. IOF troops raided 7 houses and transformed them into military sites. At approximately 06:00, IOF sent backups into the area. They raided more houses During the house raids, IOF troops wounded Zaid Salem Thabet, 14, as he attempted to escape. IOF troops also violently beat women and detained men in a house belonging to Kamal al-Telbani. At approximately 07:00, a number of activists of the Palestinian resistance exchanged fire with IOF troops. As a result of the exchange of fire, 3 resistance activists were killed:

- 1. Waleed Hasan Kalloub, 28;
- 2. Jihad Mousa Jaber, 19; and
- 3. Ibrahim 'Aa'ed Abu Middain, 24.

IOF troops opened fire indiscriminately. A tank shell fired by IOF troops fell near a slaughter site in the ear of the neighboring al-Maghazi refugee camp. Five Palestinian civilians were wounded, including 7-year-ol Qais Sami Jaber.

At approximately 08:30, Nihad Khalil Shana'a, 30, a cameraman of Reuters, was wounded by a gunshot fi by IOF troops to the left thigh, when he was filming the military operation in the area.

At approximately 09:30, IOF troops opened fire at a number of activists of the Palestinian resistance, killin one of them, 28-year-old Mahmoud Mahmoud al-Mis'hal.

At approximately 14:00, 3 activists of the Palestinian resistance clashed with IOF troops positioned atop of house belonging to Mohsen al-Musaddar. The three activists were killed in the clash:

- 1. Hamza Salem Abu Tiour, 24;
- 2. Samer Helmi Abu Saif, 23; and
- 3. Khalil Bajes al-'Eissawi, 22.

At approximately 15:20, an IOF aircraft fired a missile at a number of activists of the Palestinian resistance al-Maghazi refugee camp. As a result, a resistance activist, 22-year-old Naim Suleiman al-'Arrouqi, was killed, and Rami Tayseer Abu Dayyah, 22, correspondent of the local al-Aqsa TV, was wounded by shrapr to the head.

IOF continued to shell at houses. Two missiles hit a house belonging to 'Abdul Hakim Ahmed al-Musadda the mayor of the village. The house was damaged and al-Musaddar's brother was wounded by shrapnel to

face and the shoulders.

During this incursion, IOF razed 73 donums of agricultural land planted with olives and citrus and partially destroyed 10 houses.

At approximately 17:00, IOF troops redeployed outside the village, taking with them at least 50 Palestinian civilians. They interrogated those civilians and then released them, excluding Khaled 'Ali Sa'id, 37.

- At approximately 01:00, IOF moved into Kufor Qaddoum village, east of Qalqilya. They raided and searched a number of houses and arrested Waleed Kamel Burhom, 38.
- At approximately 01:30, IOF moved into 'Aaida refugee camp, north of Bethlehem. They raided and searched a house belonging to the family of Tha'er Ibrahim al-Jawarish, 23, and arrested him.

Friday, 21 December 2007

• At approximately 02:00, an IOF infantry unit moved nearly 800 meters into 'Abasan village, east of Kh Yunis. A number of activists of the Palestinian resistance clashed with IOF troops. A resistance activist, 'Awadh Naji Mohammed al-Fujom, 21, from the nearby Bani Suhaila village, was seriously wounded by several gunshots throughout the body. Medical efforts to save his life failed and he was pronounced dead a approximately 06:00.

Saturday, 22 December 2007

• At approximately 23:00, IOF moved into Skafiya neighborhood to the west of the Ibrahimi Mosque in Hebron. They raided and searched a number of houses, but no arrests were reported. A number of houses were damaged.

Sunday, 23 December 2007

- At approximately 00:30, IOF moved into Abu Snaina and Deir Bahha neighborhoods in the south and west of Hebron respectively. They raided and searched a number of houses and arrested 7 Palestinian civilians:
 - 1. Jameel Zakaria al-Jamal, 23;
 - 2. Mahmoud 'Eissa Abu Snaina, 22;
 - 3. Hamza 'Othman al-'Owaiwi, 36;

- At approximately 03:00, IOF moved into al-Shuhada Triangle village, south of Jenin. They besieged a house belonging to the family of Rabee' Hussein 'As'ous, 21. They opened fire at the house and forced its residents out. They then called on 'As'ous to surrender, threatening to destroy the house if he did not. Half hour later, 'As'ous surrendered, and IOF troops arrested him.
- At approximately 15:15, IOF troops positioned at the border between the Gaza Strip and Israel, east of Deir al-Balah, opened fire at 'Abdul Rahman Salem Abu Hamam, 40, when he was with his child and a fri on a tract of land belonging to him, nearly 350 meters away from the border. No one was hurt, and the thre persons got into Abu Hamam's car to leave the area. As they were leaving the area, IOF troops fired at the again. This time, Abu Hamam was wounded by a gunshot to the back.

Monday, 24 December 2007

- At approximately 01:00, IOF moved into Beit Ummar village, north of Hebron. They raided and search a number of houses and arrested 2 Palestinian civilians:
 - 1. Rasheed Nasri Sabarna, 23; and
 - 2. Mahmoud Faisal Khamis, 24.
- At approximately 01:30, an IOF aircraft fired a missile at 3 activists of the Palestinian resistance, who were nearly 500 meters away from the border between the Gaza Strip and Israel, east of al-Boreij refugee camp. Two activists were killed:
 - 1. 'Atallah Ahmed al-'Awawda, 25; and
 - 2. Jom'a Mefleh Abu Hjayer, 25.
- At approximately 10:00, IOF moved into 'Azzoun village, east of Qalqilya, and opened fire at houses a shops. Dozens of Palestinian children gathered and threw stones at IOF military vehicles. Immediately, IO troops fired at the children wounding 2 of them:
 - 1. Eyad 'Abdul Qader Swaidan, 16, wounded by a rubber-coated metal bullet to the head; and
 - 2. Yazeed Hussein 'Enaya, 6, wounded by a rubber-coated metal bullet to the left foot.

Tuesday, 25 December 2007

- At approximately 01:00, IOF moved into Marda village, north of Salfit. They raided and searched a number of houses and arrested 10 Palestinian civilians, including a child:

Wednesday, 26 December 2007

- At approximately 01:00, IOF moved into Nablus and neighboring refugee camps. They raided and searched a number of houses and arrested 4 Palestinian civilians:
 - 1. Ghassan Bassam Shatawi, 21;
 - 2. Radi Nemer Hashash, 20;
 - 3. 'Abdul Rahman Khaled Abu Jnaid, 19; and
 - 4. Haitham Sa'id 'Atalllah, 28.
- At approximately 01:30, IOF moved into Roujib village, east of Nablus. They raided and searched a number of houses and arrested 2 Palestinian civilians:
 - 1. 'Abdul Karim Majed al-Halabi, 33; and
 - 2. Eyad Mohammed Dwaikat, 35.
- At approximately 02:30, IOF moved into Kufor Qallil village, east of Nablus. They raided and searched number of houses and arrested 2 Palestinian civilians:

- At approximately 03:00, IOF moved into Til village, southwest of Nablus. They raided and searched a number of houses and arrested 2 Palestinian civilians:

2. Extra-Judicial Executions

- At approximately 20:30 on Monday, 17 December 2007, an IOF aircraft fired a missile at civilian car (a white Skoda), in which the commander of the al-Quds Brigades (the armed wing of Islamic Jihad) and his bodyguard were traveling, in al-Nasser Street in the north of Gaza City. The missile hit the car and killed the two occupants:
 - 1. Majed Yousef al-Harazin, 35, from al-Shoja'eya neighborhood in Gaza City, commander of the al-Quds Brigades; and
 - 2. Jihad al-Sayed Dhaher, 39, from al-Karama neighborhood in Gaza City, his bodyguard.

Additionally, 5 children living in the area of the attack were wounded:

- 1. Mohsen Hasan Skaik, 16, wounded by shrapnel to the chest;
- 2. Yousef Hasan Skaik, 12, wounded by shrapnel throughout the body;
- 3. Mahmoud 'Essam 'Adas, 17, wounded by shrapnel throughout the body;
- 4. Ahmed Riadh al-Hayek, 16, wounded by shrapnel to the head and the feet; and
- 5. Kamal Ahmed al-Sourani, 16, wounded by shrapnel throughout the body.
- At approximately 23:30 also on Monday, IOF troops positioned at the border between the Gaza Strip ar Israel, east of Gaza City, fired a surface-to-surface missile at 4 activists of the al-Quds Brigades (the armed wing of Islamic Jihad), who were walking in al-Zaytoun neighborhood in Gaza City, nearly 3,000 meters away from the border. The four activists were killed:
 - 1. Ayman 'Abdul Latif al-'Eila, 25, from al-Shati refugee camp;
 - 2. Kareem Marwan al-Dahdouh, 24, from al-Zaytoun neighborhood;
 - 3. Na'ed Rushdi Tafesh, 34, from al-Zaytoun neighborhood; and
 - 4. 'Ammar Abu Sa'id, 34, from al-Sabra neighborhood.
- At approximately 05:30 on Tuesday, 18 December 2007, an IOF aircraft fired a missile at 4 activists of al-Quds Brigades (the armed wing of Islamic Jihad), who were walking in Block 9 in the densely populated Jabalya refugee camp in the central Gaza Strip, after they had prayed in al-Tawba Mosque. The four activities were killed:
 - 1. Mohammed Sa'id al-Taramsi, 34;
 - 2. Sameer 'Awadallah Baker, 33;
 - 3. Ussama 'Ali Yassin, 32; and
 - 4. Hussam Mahmoud Abu Jabal, 36.

Five civilian bystanders were also wounded:

- 1. Fat'hi Mohammed Zumlot, 55;
- 2. Mohammed Hasan Ahmed, 41;

- 3. As'ad Wajeeh Msallam, 28;
- 4. Yasser Bassem Abu Jalala, 26; and

3. Continued Siege on the OPT

IOF have continued to impose a tightened siege on the OPT and imposed severe restrictions on the movement Palestinian civilians in the Gaza Strip and the West Bank, including Occupied East Jerusalem.

Gaza Strip

IOF have continued to close all border crossings of the Gaza Strip for nearly 18 months. The total siege imposed by IOF on the Gaza Strip has left disastrous impacts on the humanitarian situation and has violated the economic and social rights of the Palestinian civilian population, particularly the rights to appropriate living conditions, health and education. It has also paralyzed most economic sectors. Furthermore, severe restrictions have been imposed on the movement of the Palestinian civilian population. Moreover, the siege imposed on the Gaza St has severely impacted the flow of food, medical supplies and other necessities such as fuel, construction materials and raw materials for various economic sectors. IOF have further tightened the siege imposed on the Gaza Strip since Hamas' takeover of the Gaza Strip, and the living and economic conditions of Palestinian civilians have further deteriorated. During the reporting period, the Israeli government declared the Gaza Strip "a hostile entity," which implies imposing more restrictions and measures of collective punishment against the Palestinian civilian population.

- Rafah International Crossing Point: Rafah International Crossing Point on the Egyptian border is the so outlet for the Gaza Strip to the outside world. IOF have closed Rafah International Crossing Point, even though they do not directly control it. They have prevented European observers working at the crossing po form reaching it. The crossing point has been closed since 25 June 2006. Thousands of Palestinian civilian had been stuck at the Egyptian side of the crossing, and 24 of them, including 8 women and a child, had di The bodies were returned to Gaza through the Karm Abu Salem (Kerem Shalom) crossing. In addition, thousands of travelers were allowed to return to the Gaza Strip through al-Ojah crossing, 8 kilometers to the east of Rafah International Crossing Point. From there, they were transported to Erez Checkpoint to enter the Gaza Strip. Hundreds of Palestinian civilians who have residencies in other countries were allowed to travely out of the Gaza Strip the same way. The problem has emerged again as at least 1,500 Palestinians have been stuck at the Egyptian side of Rafah International Crossing Point waiting to be allowed to travel back to the Gaza Strip. Additionally, 30 Palestinians have been stuck at al-'Areesh Airport in Egypt. On 3 and 4 December 2007, the Egyptian authorities allowed 2,200 Palestinian pilgrims to pass through Rafah International Crossing Point to travel to Saudi Arabia.
- Beit Hanoun (Erez) Crossing: IOF have completely closed Beit Hanoun (Erez) crossing, which links the

Gaza Strip with Israel and the West Bank. Before this latest closure, IOF had prevented Palestinian workers from reaching their work places inside Israel through Beit Hanoun (Erez) crossing. Hundreds of thousands of Palestinians from the Gaza Strip had been prevented from traveling through this crossing. A few Palestinian patients have been able to travel to hospitals in Israel and the West Bank. During the reporting period, IOF allowed 520 Christians to travel from the Gaza Strip to Bethlehem for the Christmas. On 16 and 17 December 2007, 700 pilgrims were allowed to pass through the crossing to travel to Egypt and Saudi Arabia, but 150 oth were prevented. A few Palestinian patients have been able to travel to hospitals in Israel and the West Bank. To following table the number of patients who were allowed to pass through the crossing during the reporting period to travel to hospitals in Israel and the West Bank:

- <u>Al-Mentar (Karni) Commercial Crossing:</u> During the reporting period, IOF partially reopened the crossing for several hours on 4 days, to allow the entry of 216 containers of animal feeds.
- Nahal Ouz crossing: It is designed for the entry of fuels into the Gaza Strip. On 28 November 2007, IO decided a new reduction in the supply of fuel to the Gaza Strip, which already suffers from serious shortage in fuel. It is noted that this decision preempted a pending decision by the Israeli High Court on a petition submitted by PCHR and several human rights organizations against the IOF decision on 25 October 2007 to reduce the fuel and electricity supplies to the Strip. The Israeli High Court held a session on 30 November review the petition and it rejected it. Statistics indicate that the Strip's fuel supply was reduced by more that 50% since the IOF decision was issued on 25 October 2007. During the reporting period, IOF increased the amounts of gasoline allowed into the Gaza Strip to 250,000 liters a day, and benzene to 70,000 liters a day. The amount of natural gas allowed into the Gaza Strip has dropped to 100 tons a day due to a technical problem.
- <u>Sofa Crossing:</u> During the reporting period, IOF partially reopened the crossing for 3 days allowing the er of cows, humanitarian aids and some goods. On 16 and 17 December 2007, IOF allowed the entry of 1,900

cows, sheep and camels into the Gaza Strip. On 23 December 2007, IOF allowed the entry of 15 containers of flour for UNRWA and 15 containers of fruits for local traders. On 24 December 2007, IOF allowed the entry 14 containers of flour for UNRWA and 14 containers of fruits for local traders. On 25 December 2007, IOF allowed the entry of 15 containers of foodstuffs and 15 containers of fruits for local traders.

• Karm Abu Salem (Kerem Shalom) Crossing: During the reporting period, the crossing witnessed active movement. On 12 December 2007, 53 containers of goods and humanitarian aids were allowed into the Gaza Strip, and 2 containers of flowers were exported. On 13 December 2007, 56 containers of goods for local trad and humanitarian aids were allowed into the Gaza Strip, and 6 containers of strawberries and flowers were exported. On 14 December 2007, 7 containers of goods for local traders were allowed into the Gaza Strip. On December 2007, 33 containers of goods were allowed into the Gaza Strip, and 4 containers of flowers and strawberries were exported. On 18 December 2007, 34 containers of goods and humanitarian aids were allowed into the Gaza Strip, and 4 containers of flowers were exported. On 19 December 2007, 5 containers of goods were allowed into the Gaza Strip, and 2 containers of flowers were exported. On 21 December 2007, 44 containers goods and humanitarian aids were allowed into the Gaza Strip, and 2 containers of flowers were exported. On 21 December 2007, 47 containers goods were allowed into the Gaza Strip and 2 containers of flowers were exported. On 24 December 2007, 58 containers of goods were allowed into the Gaza Strip and 2 containers of flowers were exported. On 25 December 2007, 65 containers of goods were allowed into the Gaza Strip, and 2 containers of flowers were exported. On 25 December 2007, 65 containers of goods were allowed into the Gaza Strip, and 2 containers of flowers were exported.

PCHR is following up with utmost concern the deterioration to the economic and social conditions resulted from the total siege imposed by Israeli occupation authorities on the Occupied Palestinian Territory, especiall the Gaza Strip. PCHR is worried from further deterioration of the living conditions of the Palestinian civilian population if the recommendations of the security committee were implemented, as at least 60% of the Palestinian civilian population would be deprived of electricity supplies and many civilian facilities that provivital services would stop providing services to the civilian population due to the lack of electricity supplies.

The closure of border crossings deprives the Palestinian civilian population in the Gaza Strip of their right to freedom of movement, education and health. IOF have continued to impose severe restrictions on fishing in the Gaza Strip. Following the attack on IOF on 25 June 2006, IOF prevented fishing. Approximately 35,000 peop in and around Gaza's coastal communities rely on the fishing industry, including 2,500 fishermen, 2,500 suppostaff and their families. Fishermen have been subjected to intensive monitoring by IOF, which use helicopter gunships and gunboats to monitor the fishermen. The Oslo Accords allow Palestinian fishermen to go fishing to 20 nautical miles away from the Gaza seashore.

The West Bank

IOF have imposed a tightened siege on the West Bank. They have continued to impose severe restrictions on movement of Palestinian civilians and imposed curfews on a number of Palestinian communities.

• Jerusalem: IOF have continued to impose severe restrictions on the movement of Palestinian civilians to a

from the city. Thousands of Palestinian civilians from the West Bank and the Gaza Strip have been denied access to the city. IOF have established many checkpoints around and inside the city. Restrictions of the movement of Palestinian civilians often escalate on Fridays to prevent them from praying at the al-Aqsa Mosque. IOF often violently beat Palestinian civilians who attempt to bypass checkpoints and enter the city. I impose severe restrictions on the movement of Palestinian civilians on Fridays to restrict their access to the al Aqsa Mosque.

• Bethlehem: IOF have imposed additional restrictions on the freedom of movement, including the access of pilgrims to the holy sites in the town. On Saturday evening, 22 December 2007, IOF troops positioned at a permanent checkpoint established at the southwestern entrance of Bethlehem conducted prolonged checking of Palestinian civilians. at approximately 10:00 on Sunday, 23 December 2007, IOF closed the Container checkpoint, northeast of Bethlehem. The closure continued for 2 hours, following which IOF troops conducted prolonged checking on Palestinian civilians wishing to pass through the checkpoint. On Monday, 24 December 2007, IOF reinforced their presence at Ras Beit Jala checkpoint, west of Bethlehem. They imposed severe restrictions on the movement of Christian pilgrims wishing to enter the town.

On Tuesday noon, 11 December 2007, IOF troops positioned at the Container checkpoint, northeast of Bethlehem, arrested 2 Palestinian civilians from the Gaza Strip: Murad Khalil Hasan al-Wawi, 29; and Husse Khalil al-Wawi, 27.

• <u>Hebron:</u> IOF have continued to impose severe restrictions on the movement of Palestinian civilians inside and around the town. On Friday and Saturday, 14 and 15 December 2007, IOF imposed severe restrictions on movement of Palestinian civilians in Hebron. They stopped and checked Palestinian civilians. During the Eid Adha, IOF imposed additional restrictions on the movement of Palestinian civilians in the center and the south Hebron. They stopped and conducted prolonged checking on those civilians.

At approximately 05:00 on Sunday, 23 December 2007, IOF troops positioned at the eastern entrance of Be Ummar village, north of Hebron, fired at Mohammed Mahmoud 'Awadh, 21, when he wanted to get out of the village. He was wounded by a gunshot to the right foot. IOF troops then arrested him.

• <u>Nablus:</u> IOF have continued to impose severe restrictions on the movement of Palestinian civilians. During the Eid al-Adha days, IOF imposed additional restrictions on the movement of Palestinian civilians. They closed checkpoints from time to time. At the end of the holidays of the Eid, IOF troops positioned at various checkpoints around the city imposed severe restrictions on the movement of Palestinian civilians, especially employees wishing to travel to their work places in Ramallah.

At approximately 16:30 on Saturday, 8 December 2007, IOF closed Hawara checkpoint, south of Nablus. They arrested Jihad Mahmoud Bisharat, 16, claiming that he was carrying explosives.

At approximately 08:30 on Sunday, 9 December 2007, IOF troops positioned at Hawara checkpoint, south Nablus, arrested 'Abdul Latif Mohammed Nabhan, 55, from Jenin.

At approximately 10:00 on Monday, 10 December 2007, IOF troops positioned at Za'tara checkpoint, sout of Nablus, arrested Rashad Basem Melhem, 25, from Tulkarm.

On Monday noon, IOF troops positioned at al-Karama International Crossing Point on the Jordanian borde arrested Saif Abu Keshek, 28, from 'Askar refugee camp northeast of Nablus, when he was on his way bac to the West Bank.

- <u>Tulkarm:</u> IOF have continued to impose severe restrictions on the movement of Palestinian civilians. O Thursday, 13 December 2007, IOF closed Wad al-Teen checkpoint, south of Tulkarm. On Sunday, 16 December 2007, IOF erected a checkpoint at the southern entrance of Deir al-Ghosoun village, north of Tulkarm. They stopped and searched Palestinian civilian vehicles. On Tuesday, 18 December 2007, IOF closed all military checkpoints leading to Tulkarm, and prohibited the movement of Palestinian civilians to and from the town. On Wednesday, 19 December 2007, the first day of the Eid al-Adha, IOF imposed additional restrictions on the movement of Palestinian civilians. On Thursday, 20 December 2007, IOF erected a checkpoint at the entrance of Bala'a village, east of Tulkarm, and prohibited the movement of Palestinian civilians to and from the town. On Sunday, 23 December 2007, IOF closed Ennab checkpoint, east of Tulkarm until the noon.
- <u>Jenin:</u> At approximately 15:00 on Tuesday, 25 December 2007, IOF troops positioned at a checkpoint of Sanour-Qabatya road, southeast of Jenin, arrested Fadi Ghazi al-Sa'di, 24, from Jenin, when he was travelit to the town.

4. Construction of the Annexation Wall

IOF have continued to construct the Annexation Wall inside West Bank territory. During the reporting period IOF used force against peaceful demonstrations organized by Palestinian civilian in protest to the construction the Wall in Bal'ein village, west of Ramallah, and al-Ma'sara village, south of Bethlehem.

- Following the Friday Prayer on 14 December 2007, scores of Palestinian civilians and international and Israeli human rights defenders demonstrated in Bal'ein village, west of Ramallah, in protest to the construction of the Wall. IOF troops had placed barbwires in the area to prevent the demonstrators from reaching the Wall. The demonstrators attempted to move forward. Immediately, IOF troops fired rubber-coated metal bullets, sound bombs and tear gas canisters at the demonstrators, and violently beat them. As result, 4 demonstrators were wounded:
 - 1. Samed Hani Abu Rahma, 18, wounded by a rubber-coated metal bullet to the leg;
 - 2. Mohammed Ahmed Yassin, 18, wounded by a rubber-coated metal bullet to the leg;
 - 3. 'Omar Hisham Nasser, 24, wounded by a rubber-coated metal bullet to the leg; and
 - 4. Ibrahim 'Abdul Fattah Bernat, 25, wounded by a rubber-coated metal bullet to the leg.
- Following the Friday Prayer also on 14 December 2007, scores of Palestinian civilians and internationa and Israeli human rights defenders demonstrated in al-Ma's ara village, south of Bethlehem, in protest to the construction of the Wall. IOF troops had placed barbwires in the area to prevent the demonstrators from

reaching the Wall. The demonstrators attempted to move towards the Wall. Immediately, IOF troops fired rubber-coated metal bullets, sound bombs and tear gas canisters at the demonstrators, and violently beat the As a result, 2 demonstrators sustained bruises:

- 1. Saleem Mohammed al-'Omour, 29; and
- 2. Lu'ai Hussein Braijiya, 25.
- At approximately 14:30 on the same day, IOF troops positioned near the Wall, southwest of Hebron, fin at Mohammed Ahmed al-Hroush, 30, from Mnaizel village, south of Hebron, when he was on his way to hall land, which is located near the Wall. He was wounded by a gunshot to the left foot.
- Following the Friday Prayer on 21 December 2007, scores of Palestinian civilians and international and Israeli human rights defenders demonstrated in Bal'ein village, west of Ramallah, in protest to the construction of the Wall. IOF troops had placed barbwires in the area to prevent the demonstrators from reaching the Wall. The demonstrators attempted to move forward. Immediately, IOF troops fired rubber-coated metal bullets, sound bombs and tear gas canisters at the demonstrators, and violently beat them. As result, 5 demonstrators were wounded:
 - 1. Ashraf Mohammed al-Khatib, 25, wounded by a rubber-coated metal bullet to the leg;
 - 2. Clayton, 24, an American human rights defender, hit by a tear gas canister to the head;
 - 3. Eyad Mohammed Bernat, 24, hit by a tear gas canister to the leg;
 - 4. Mahdi 'Abdul Mo'men Abu Rahma, 18, wounded by a rubber-coated metal bullet to the leg; and
 - 5. Ibrahim 'Abdul Fattah Bernat, 25, wounded by a rubber-coated metal bullet to the leg.
- Following the Friday Prayer also on 21 December 2007, scores of Palestinian civilians and international and Israeli human rights defenders demonstrated in al-Ma's ara village, south of Bethlehem, in protest to the construction of the Wall. IOF troops had placed barbwires in the area to prevent the demonstrators from reaching the Wall. The demonstrators attempted to move towards the Wall. Immediately, IOF troops fired rubber-coated metal bullets, sound bombs and tear gas canisters at the demonstrators, and violently beat the As a result, 3 demonstrators sustained bruises. IOF troops also arrested Mohammed Hasan Braijiya, 53.

5. Settlement Activities and Attacks by Settlers against Palestinian Civilians and Property

IOF have continued settlement activities in the OPT in violation of international humanitarian law, and Israeli settlers have continued to attack Palestinian civilians and property.

• At approximately 11:00 on Tuesday morning, 25 December 2007, IOF moved into Wad al-Jouz neighborhood in East Jerusalem. They besieged a 70-square-meter house belonging to Akram al-'Owaiwi, which 6 people live. They forced the residents out and did not allow them to vacate any of their belongings

IOF then demolished the house.

• At approximately 11:15 on the same day, a number of Israeli settlers attacked 3 Palestinian civilians, including a child, southwest of Nablus. One of those civilian sustained a facture to the left forearm and a lacut to the head.

In his testimony to PCHR, the victim, Hashem Mustafa Hamad, 50, stated:

"At approximately 11:15 on Tuesday, 25 December 2007, I was farming my land in the southwest of Til village, southwest of Nablus, nearly 100 meters a way from a settler bypass road, and 50 meters away from the newly-established 'Gilad' settlement. Hussein Ahmed Ayoub, 45, was helping me, and my nephew, 16-year-old 'Omar Hisham Hamad, was grazing animals in the area. Soon, I saw 5 masked Israeli settlers moving towards us. I shouted on them: 'Back. Back.' However, they proceeded towards us. They surrounded us and one of them took out a gas canister, from which he sprayed on Ayoub's face. Ayoub cried and fell onto the ground. I attempted to pick up a stone to throw it at the settler, but he sprayed gas into my right eye. He then hit me with a stick on my head. Ayoub and my nephew fled. All settlers gathered around me and violently beat me. A few minutes later, Ayoub brought a taxi, which evacuated me to Rafidya Hospital in Nablus."

Recommendations to the International Community

- 1. PCHR calls upon the High Contracting Parties to the Fourth Geneva Convention to fulfill their legal a moral obligations under Article 1 of the Convention to ensure Israel's respect for the Convention in the Occupied Palestinian Territory. PCHR believes that the conspiracy of silence practiced by the internation community has encouraged Israel to act as if it is above the law and encourages Israel continue to violate international human rights and humanitarian law.
- 2. PCHR calls upon the High Contracting Parties to the Fourth Geneva Convention to convene a confere to take effective steps to ensure Israel's respect of the Convention in the OPT and to provide immediate protection for Palestinian civilians.
- 3. PCHR calls upon the High Contracting Parties to the Fourth Geneva Convention to comply with its le obligations detailed in Article 146 of the Convention to search for and prosecute those responsible for grabreaches, namely war crimes.
- 4. PCHR calls for the immediately implementation of the Advisory Opinion issued by the International

Court of Justice, which considers the construction of the Annexation Wall inside the West Bank illegal.

- 5. PCHR recommends international civil society organizations, including human rights organizations, bat associations and NGOs to participate in the process of exposing those accused of grave breaches of international law and to urge their governments to bring these people to justice.
- 6. PCHR calls upon the European Union to activate Article 2 of the Euro-Israel Association Agreement, which provides that Israel must respect human rights as a precondition for economic cooperation between EU states and Israel. PCHR further calls upon the EU states to prohibit import of goods produced in illeg. Israeli settlements in the OPT.
- 7. PCHR calls on the international community to recognize the Gaza disengagement plan, which was implemented last year, for what it is not an end to occupation but a compounding of the occupation and thumanitarian crisis in the Gaza Strip.
- 8. In recognition of ICRC as the guardian of the Fourth Geneva Convention, PCHR calls upon the ICRC increase its staff and activities in the OPT, including the facilitation of family visitations to Palestinian prisoners in Israeli jails.
- 9. PCHR appreciates the efforts of international civil society, including human rights organizations, bar associations, unions and NGOs, and urges them to continue their role in pressuring their governments to secure Israel's respect for human rights in the OPT and to end its attacks on Palestinian civilians.
- 10. PCHR calls upon the international community to pressure Israel to lift the severe restrictions imposed the Israeli government and its occupation forces on access for international organizations to the OPT.
- 11. PCHR reiterates that any political settlement not based on international human rights law and humanitarian law cannot lead to a peaceful and just solution of the Palestinian question. Rather, such an arrangement can only lead to further suffering and instability in the region. Any peace agreement or proceed must be based on respect for international law, including international human rights and humanitarian law
