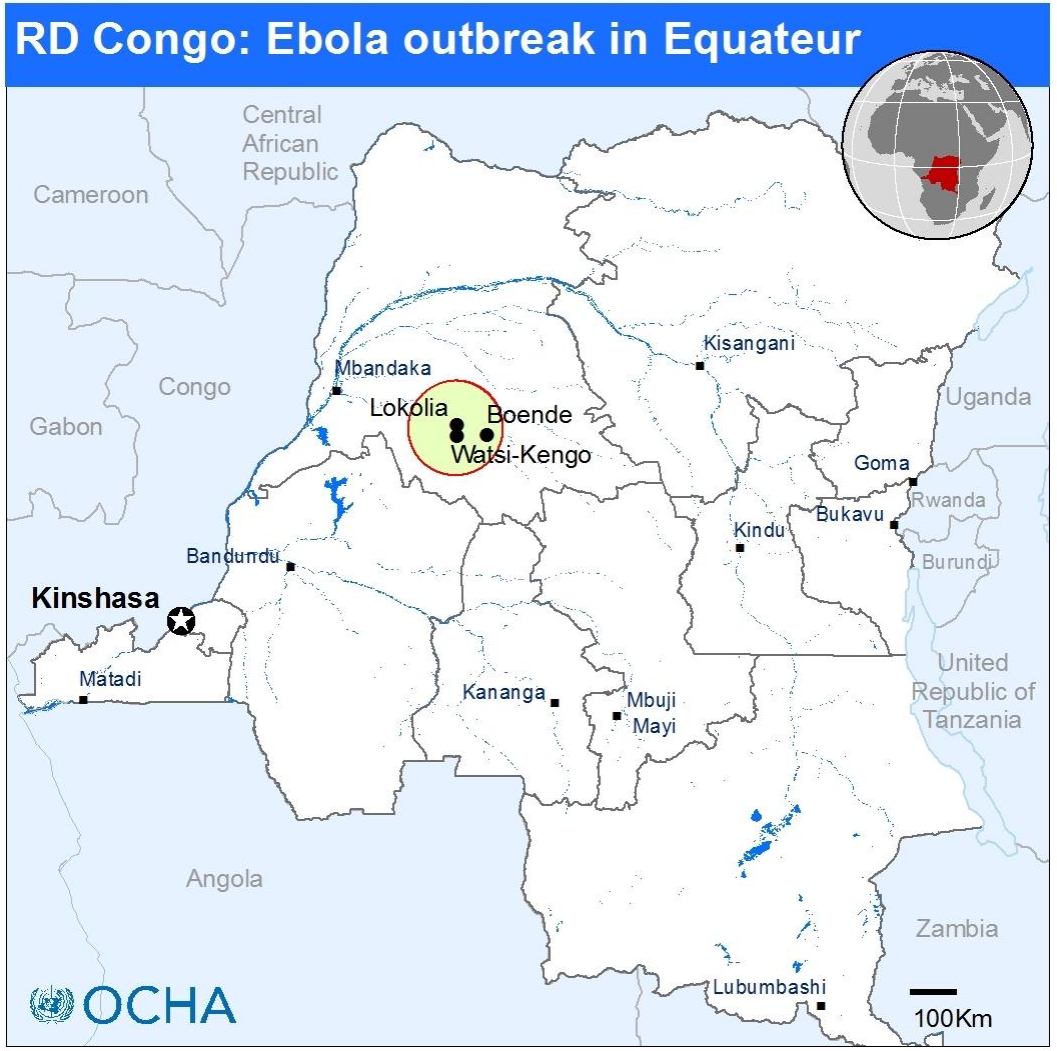

Coordination/ Keys developments

- *The number of suspected cases has fallen, as some have been laboratory confirmed.
- **12 alerts including one with death in Kokolo military camp in Kinshasa, a second reported in Kambove in Katanga and 10 cases of which 8 deaths reported in Bongandanga, Equateur Provincier. Five samples from Bongandanga and from Nyakunde in Ituri (Orientale Province) are being analyzed.
- Between 2 and 10 September, 35 cases of EVD have been reported in the area of Djera in Equateur Province in DRC, increasing the cumulative number of cases to 66 (see the above table for details).
- Two additional treatment centers are operational since 9 September with the capacity of 50 beds
- Some local/provincial committees of the CNC (Ebola response coordination) are not operating optimally like Kinshasa; some coordination tools for the smooth functioning of these structures at local / provincial level are

<p>still unavailable</p> <ul style="list-style-type: none"> • Epidemic Control Commission (ECC) has submitted a health roadmap on the management and prevention of the Ebola Virus Disease to the DRC Minister of Health as per recommendations of the latest meeting of SADEC Ministers of Public Health held in Zimbabwe. • Two hotline numbers have been set up to allow the population to get information on the disease and ongoing efforts: 081 08 000 20 and 099 99 710 05. An additional hotline for information on the prevention of the EVD is available using Tigo: 119. • The contingency plan for Kinshasa has been finalized, but actions for its full activation are yet to be taken.
<p>Security and Logistics</p> <ul style="list-style-type: none"> • The bad state of the road between Boende and Lokolia is one of the main logistic constraints, disrupting routing of heavy equipment and other medical inputs necessary for the fight against EVD. The government has instructed the Office de Route for a rapid rehabilitation of this road section. • INRB needs a regular fuel supply to deal with untimely power outages by the SNEL during laboratory tests <p>Flights schedule</p> <ul style="list-style-type: none"> • UNHAS <ul style="list-style-type: none"> ◦ Tuesday and Saturday : Kinshasa – Mbandaka – Boende - Kinshasa for passengers and limited cargo • ASF- France <ul style="list-style-type: none"> ◦ Monday, Wednesday and Friday : Mbandaka – Boende - Mbandaka for passengers and/or cargo • MONUSCO <ul style="list-style-type: none"> ◦ Support with cargo flights and helicopters for passengers and cargo • OMS et UNICEF : Receive and process flight requests in line with field priorities
<p>Ongoing activities</p> <ul style="list-style-type: none"> • Delivery of the first batch of 1,000 NFI-WASH kits in Lokolia where access to water is still very limited • Construction of an EVD treatment center within Kinkole Hospital as a preventive measure recommended in the contingency plan for the city of Kinshasa • Investigation of the traceability of two positive cases registered in Boende to determine if they belong to the same pattern of contamination as the index EVD case in Lokolia • Continuing sensitization of community leaders, community radios, teachers, etc. on EVD and hygiene practices • Free medical treatment to all patient in the affected areas
<p>Planned activities</p> <ul style="list-style-type: none"> • The first weekly press briefing will be held on 12 September at the “Centre Interdiocésain” of Kinshasa. It is organized by the Communication Commission with the support of C-Change. • Manual drilling in Lokolia : talks continue between the NGO CADECOD, UNICEF and WASH Commission to launch the drilling • Briefing of Kinshasa-based diplomatic corps on the measures taken by the Government for the management and prevention of the Ebola disease • Sensitizing police officers and other security agents to prevent harassment of travelers along the Congo River
<p>Gaps</p> <ul style="list-style-type: none"> • INRB’s laboratory in Kinshasa is out of stock of reagents after supplying all its reagents stocks to the mobile laboratory in Lokolia • Human Resources: More medical staff needed in Mbandaka, Boende and Watsikengo • Poor road conditions between Boende and Lokolia is affecting the transport of medical equipment. Urgent rehabilitation of the road between Boende Lokolia, Mokoko and Watsikengo is needed • Diesel
<p>Funding</p> <ul style="list-style-type: none"> • Needs : USD 8,6 million • DRC Government : USD 1 million • Common Humanitarian Fund : USD 2,7 million approved by the Humanitarian Coordinator • CERF : USD 2,45 million (ongoing) • MONUSCO : Amount to be confirmed • MSF : Amount to be confirmed • Gap : USD 2,46 million
