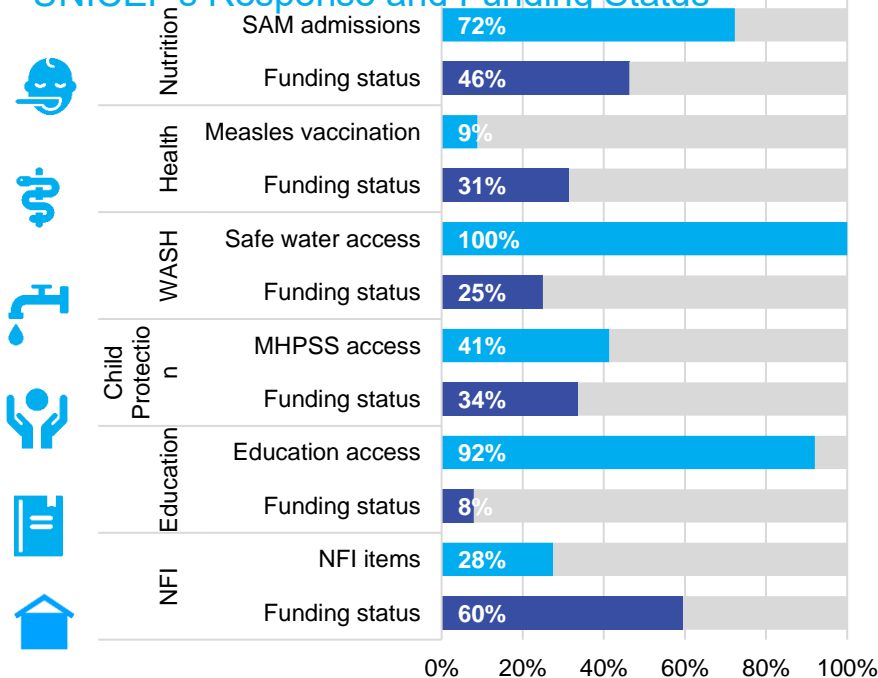
Highlights

- As of September 21, 549,049 people (69,485 households) were affected and 69 people lost their lives due to the floods. The overall record of losses and damage spreads over the 08 regions with a total of 43,226 collapsed houses and other 1,569 damaged.
- On September 18, 01 soldier was killed when a vehicle of the Nigerien armed forces was hit by an improvised explosive device between Bosso and Baroua (Diffa region), and an ambulance was hijacked on 28th of September by unidentified armed men in Toumour (Diffa).
- The Rapid Response Mechanism (RRM) recorded 01 alert on displacement of people following non-state armed groups attacks and conducted 05 rapid assessments (04 multi-sector assessments, 01 rapid protection assessments) in the Diffa and Maradi regions. RRM actors also provided NFI assistance to 456 displaced households for 4,289 beneficiaries.
- 3,417,370 children under 5 in 4 a new cVDPV2 outbreak regions are vaccinated against Polio.
- The lack of social workers at the Regional Directorate for Child Protection affected the case management of vulnerable children on a regular basis in Diffa. Human resources are urgently needed to sensitize the community on child protection and prevention actions, and to strengthen programs in order to accompany abducted children who have escaped or have been released by the non-state armed groups. Furthermore, access remains a challenge in some areas such as Bosso, Toumour and Gueskerou due to insecurity.

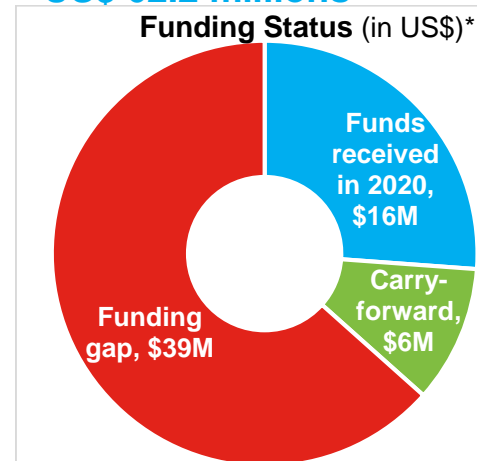

** Regarding the Education sector, the high rate of results compared with the low funding level is mainly due to the utilisation of stock ordered in 2019 and the use of non-emergency funds, in particular for the response to emergencies in Diffa, Tahoua, and Tillaberi regions (regular resources, NORAD funds, Education Cannot Wait contributions).

Funding Overview and Partnership

In 2020, UNICEF is appealing for US\$ 62.2M to provide life-saving services to women and children affected by several crisis in Niger, in coordination with other humanitarian actors, within the framework of the revised Humanitarian Response Plan 2020, and in partnerships with the Government and NGOs. The funds carry-over from the previous year amounts to US\$ 6.5M and funding received so far amounts to about US\$ 16M, leaving a funding gap of 63 % at the end of September 2020. Nevertheless, new funds have been provided by UNOCHA (CERF) as well as ECHO, allowing UNICEF to quickly provide support to populations affected by the recent record-level floods. UNICEF expresses its sincere gratitude to all public and private donors for the contributions received.

Situation Overview & Humanitarian Needs

Humanitarian Needs Overview: The 2020 Humanitarian Response Plan was revised in July: 3.7 million people in Niger are estimated to be in need of humanitarian assistance, including about 2 million children. The needs analysis shows the persistence of five major crises affecting the country: food insecurity, malnutrition, epidemics including COVID-19 pandemic, floods and conflicts leading to population movements and trafficking and irregular migration. According to this revised version of the 2020 HRP, 2.2 million people (+27%) are targeted for non-COVID-19 response with an updated budget of 433.8 M USD (+8%). The Food Security sector increased target and budget by 33%; other sectors with a major increase in people targeted are protection, nutrition, shelter/NFI and health. The revised HRP also includes an amount of 82.3 M USD for COVID-19 response (66.6 M USD for health activities) for a new HRP total budget of 516.1 M USD. The COVID-19 HRP targets 3.1 M people in the country.

In partnership with government and NGOs, UNICEF continues to provide multisectoral and coordinated assistance to affected population, both through an emergency approach to assist the most vulnerable populations immediately after a shock, and through longer terms interventions to guarantee durable solutions.

Access continue to be very limited due to continuous insecurity and to a cumbersome civil-military coordination process. Field missions are frequently cancelled due to incidents and/or non-state armed groups activities and lack of access is slowing down program implementation and monitoring. The imposition of armed escorts by the government for all movements outside the major urban agglomerations represents a major barrier to access the affected communities: UNICEF was obliged to suspend all field missions requiring an armed escort with heavy consequences to the delivery of assistance. A dialogue is ongoing with the Government and the humanitarian community and UN Agencies.

COVID-19 pandemic¹: Following the confirmation of the first positive case of COVID-19 on March 19th, 2020 in the capital city Niamey, UNICEF has been working closely with the Government and its partners to step up the response and prevent further proliferation of the COVID-19 pandemic across the country, already facing the consequences of multiple crises (nutrition, conflicts, natural disasters). As of the end of the reporting period, Niger registered 1,197 cases of COVID-19, 1,114 patients recovered, 14 patients currently under treatment, 69 deaths, with a decreasing trend in cases and the last associated death reported since the 2nd July. Even if the situation appears calm, the rate of imported cases is high, and cases of community transmission are still reported.

Summary Analysis of Programme Response

Nutrition

UNICEF, in close collaboration with the Ministry of Health and regional and health districts, supported the treatment of SAM children nationwide. UNICEF strengthened Hygiene and Infection Prevention and Control (IPC) interventions both at health facility and community level into existing nutrition interventions to reduce the incidence of nosocomial infections and reduce the spread of COVID-19 virus, especially in the management of severe acute malnutrition.

Lake Chad Basin crisis

As 20th of September (week 38), 67,534 under-five children suffering from SAM were admitted for treatment in Tahoua and Tillaberi regions, including 8,200 children with medical complications. Compared to the same period of last year, it represented an increase of 5% in inpatient and 3% in outpatient facilities.

Mali Border crisis (Tahoua and Tillaberi regions)

As of September 20 (week 38), 67,534 under-five children suffering from SAM were admitted for treatment in Tahoua and Tillaberi regions, including 8,200 children with medical complications. Compared to the same period of last year, it represented an increase of 5% in inpatient and 3% in outpatient facilities.

National crisis

As 20th of September (week 38), 275,216 under-five children suffering from SAM were admitted for treatment (representing 69,6% of the annual target), including 31,618 cases with medical complications. Compared to the same

period of last year, it represented a decrease of 1% in inpatient facilities but an increase of 12% in outpatient facilities. As of the end of the September, performance indicators are the following: 91,7% of children cured, 1.4% of children died and default rate of 4.2%. The data collection of the national nutrition survey started in September and will continue until mid-October. The preliminary results are expected for the end of October. In addition, the seasonal malaria chemoprophylaxis (SMC) and the national immunization campaigns held in September targeted 6.04 million and 3.9 million of children respectively for the screening of acute malnutrition and for Vitamin A supplementation.

COVID-19 ADAPTATION

UNICEF is supporting the Government of Niger and partners on the implementation of adapted modalities to ensure the continuity of essential nutrition services at health facility and community level. During the reporting period, hand washing kits and masks were made available to the 5 intensive nutritional recovery centres (CRENI) in Niamey with UNICEF support. Furthermore, UNICEF provided technical support to the nutrition directorate in setting up a monitoring and evaluation system with tools for collecting data on the COVID-19 response. Joint supervision visits are carried out in order to assess the effectiveness of the response at the health facility level.

Health

Managing the Poliomyelitis Outbreak (Mali Border Tahoua and Tillaberi regions, Dosso an Niamey regions)

In September 2020, UNICEF and its partners to respond to a new cVDPV2 outbreak held a round in the regions of Dosso, Niamey, Tahoua and Tillaberi. For a target of 3,417,370 children in the 4 regions of the response, 3 146 654 children (92%) are vaccinated.

Lake Chad Basin crisis

Since the start of the activities of community mediators in May 2020, 6,133 women have accepted and took the HIV test as part of the antenatal care (ANC). 15 women tested positive, and 18 HIV women previously tested positive were traced, and they received ANC. During the reporting period, 1,186 women were sensitized at the maternity hospital to HIV screening, and 1,289 women went to the HIV testing. Among them, 3 women tested positive to HIV. 324 spouses of women were sensitized on the HIV screening and 227 of these spouses accepted the test. As a result, 4 of them were tested positive and 14 exposed children are currently being followed. About 100 women, most of them literate, have been tested for HIV without needing the sensitization.

Mali Border crisis (Tahoua and Tillaberi regions)

Mobile clinics are continuing to be carried out in the Tillabéri region in order to reach affected populations with health care. As a result, 4,086 children under 5 were treated (413 refugees, 1,413 displaced and 2,260 indigenous children). The major diseases treated were malaria, acute respiratory infections and diarrhoea. Measles cases (07) have been recorded in the Ayorou Health District, and preparations activities are being implemented for a response with the support of UNICEF.

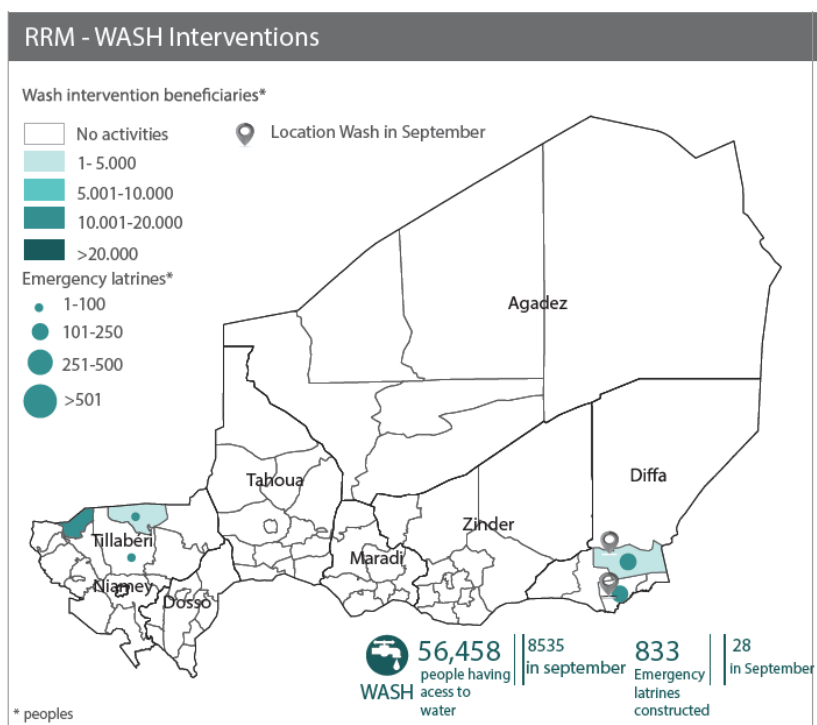

WASH

Lake Chad Basin crisis

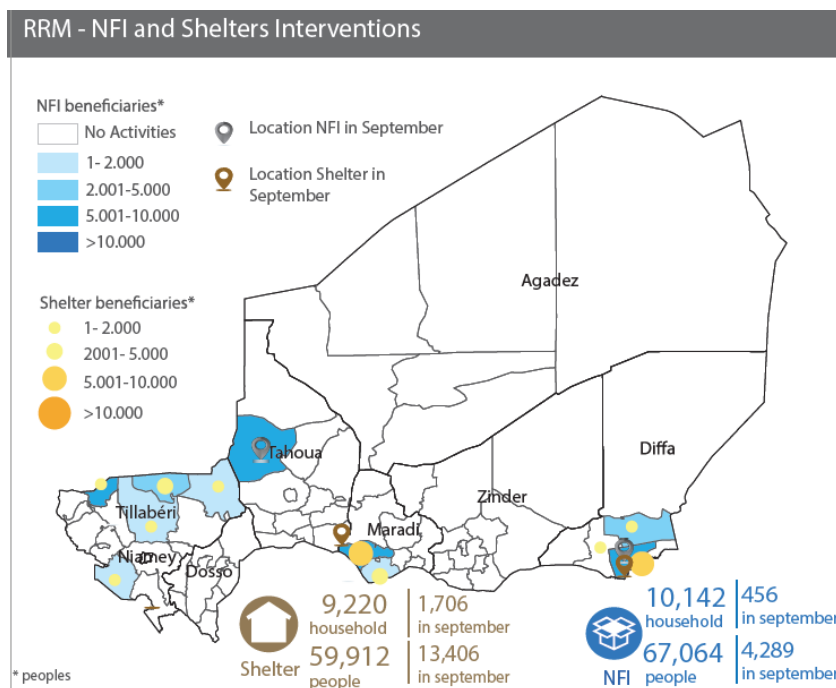
In September 2020, UNICEF and the WASH Cluster actors provided : (1) 8,535 people affected by population movement with access to safe water to respond to their immediate needs through water trucking in Digargo village (Municipality of Diffa / Region of Diffa) which rises the cluster results to 10,487 people (70% of the target); (2) 4000 people with access to sustainable water supply through the extension of a solar powered piped system in the health centres of Nayi Lawan and Nguel Beyli and in 02 school of Nguel Kolo with UNICEF support which rises the Cluster WASH results to 28,853 people (39%); (3) 59,606 people were reached with hygiene promotion and awareness raising, including sensitization on the COVID-19 prevention, in the villages of Diagargo, Kouble Igre and Chetimari, which



raises the cluster results to 135,998 people (49% of the target).

Mali border crisis (Tahoua and Tillabéri regions)

In Tillabéri region, 4,674 people were provided with access to sustainable water supply with UNICEF support, through the reinforcement of a solar powered water supply system in Ayerou village (municipality of Ayerou) in collaboration with the Regional Directorate of water and sanitation which rises UNICEF results to 11,561 people (26% of the target). Furthermore, 20,845 people affected by population movement were reached with hygiene promotion which rises UNICEF results to 70,446 people (88% of the target). 445 malnourished children were provided with soap, household water treatment product and hygiene promotion with UNICEF support through WASH-in-Nut projects in the departments of Say, Torodi, Tillabéri, Ouallam, Ayerou, Bankilare and Gotheye in Tillabéri region.



Other crises

In the department of Madaoua (Tahoua region), thanks to UNICEF support, WASH Cluster actors provided 116,970 people affected by floods with water treatment products to improve their access to safe drinking water.

COVID-19 ADAPTATION

UNICEF continues to support the national IPC commission and regional COVID-19 committees to develop and implement comprehensive WASH/IPC activities as part of the implementation of WASH in emergency response, based on the adaptation of the implementation of Humanitarian Response Plan projects. This includes awareness raising on barrier measures to prevent COVID-19 infections, training of health workers and hygienists, provision and distribution of handwashing devices and other WASH/IPC kits, reinforcement of water supply and sanitation in COVID-19 case management and other relevant healthcare facilities, hygiene promotion and monitoring of IPC measure in health centres. In this case UNICEF provided the health ministry with IPC supply and is supporting the evaluation of IPC measure in 5 regions (Dosso, Tahoua, Maradi, Zinder and Diffa).

Education

At the national level, UNICEF ordered and made available 12,101 hand washing devices and as many boxes of soap to 2,421 primary schools and 363 secondary schools. The goal of this intervention is to improve the school environment, particularly in terms of health and hygiene. The school year has been postponed by two weeks due to the flooding, which destroyed 94 classrooms; furthermore, at least 61 schools were occupied by displaced households. UNICEF has made available 1,248 tarpaulins to help created temporary learning spaces.

Lake Chad Basin crisis

As part of the support activity for the implementation of action plans for the decentralized management committees of schools (CGDES), the NGO COOPI (cluster member) has built 3 boreholes and rehabilitated 2 others in schools in the Diffa region. It has also distributed 70 hand washing devices to 35 primary schools in the same region, 35 boxes of soap, 35 disinfectant sprays and 1,750 reusable masks. Finally, it organized catch-up courses (August-September) for 732 primary school students (380 girls) from displaced populations in the Diffa region.

Mali Border Crisis (Tahoua and Tillabéri régions)

In the Tillabéri region: (1) 350 teachers (134 women) were trained on cross-cutting issues (Gender-Based Violence, child protection mechanisms, development and implementation of a system for monitoring of protection incidents cases in schools, etc.); (2) 45 temporary learning spaces (TLS) and 05 TLS for community kindergartens were rehabilitated; (3) 1,392 students (692 girls) from health and hygiene clubs were trained in good hygiene practices.

COVID-19 ADAPTATION

UNICEF has set up a multisectoral committee to support the Back to School preparations in light of the COVID-19 pandemic, to coordinate a safe, healthy and protective school environment (C4D, Communication, Child Protection,

Wash and Education). In order to improve the school environment, awareness tools including audio-visual messages are being produced and broadcasts will start in October 2020. The designs of the Back-To-School (BTS) audio and video capsules, the BTS-COVID-19 posters (A2 format) and BTS-COVID-19 flyers have been completed.

Child Protection

Lake Chad Basin crisis

In September 2020, in the region of Diffa, 3,102 children (1,559 girls) benefitted from psychosocial support by Child Protection Working Group (CPWG) members, among them 568 (245 girls) by the Regional Directorate for Child Protection (DRPE) social workers through UNICEF support. 103 separated and unaccompanied children (43 girls) as well as 65 children formerly associated with a non-state armed group benefitted from follow-up by CPWG members with UNICEF support. 3,925 children (2,047 girls) among them 655 (172 girls) through UNICEF support and 2,768 adults (1,501 women), benefitted from sensitization activities on child protection issues, COVID-19 prevention and access to social services. Six boys aged 14 to 17 were recruited by a non-state armed group in Djalori village (Diffa commune). Abductions also remain a threat for children. Restriction of movement remains a challenge in some areas such as Bosso, Toumour and Gueskerou due to insecurity. Another challenge is the lack of social workers with the DRPE, affecting the case management of vulnerable children on a regular basis. There is a need to continue community sensitization on child protection and prevention actions, but also to strengthen programs in order to accompany abducted children who have escaped or have been released by the non-state armed groups.

Mali Border Crisis (Tahoua and Tillaberi regions)

In the Tillaberi region, 93 child protection community-based mechanisms (CPCBM), youth dialogues committees and women's groups are operational in 54 villages in the region at the border with Burkina Faso through UNICEF's national partner. 318 sensitization activities were performed in small gatherings targeting 3,271 people, including 1,299 children and 84 people with disabilities (including 41 boys and 26 girls). 116 children at risk were identified by the CPCBM and benefitted from social worker follow-up and psychosocial support. Floods, movements in the area and the security situation are a challenge for the UNICEF's partner to reach the CPCBM and to provide them with adequate support. Orientations are offered via communications means (phones and portable small solar panels) and gatherings at other locations when possible.

National Level

In September 2020, the Child Protection sub-cluster collaborated with UNHCR to allocate funds to the flooding emergency response in Niger. The Protection cluster requested USD 500,000, including funds for child protection activities such as the delivery of appropriate kits (NFI), psychosocial support, birth registration activities and strengthening of community-based child protection mechanisms. Focal points of the Ministry of Child Protection presented to 18 NGOs and UN agencies the Governmental Decree on the setup of child protection community-based mechanisms. A Humanitarian Needs Overview (HNO) child protection technical group was established to work on the HNO in collaboration with the Protection cluster.

COVID-19 ADAPTATION

Despite the COVID-19 pandemic, child protection activities with protection services and partners continued during the reporting period, adapting the activities to the context via small groups gatherings for sensitization and orientations by social workers through communications means to child protection community-based mechanisms.

Non-Food Items (NFI)

The Rapid Response Mechanism (RRM) provides a multisectoral response to population affected by a shock (armed conflict, floods, epidemics) through NFI, Shelter, Food Security, Protection, WASH, Health and Nutrition emergency response. UNICEF, in close collaboration with the Ministry of the Humanitarian Action and RRM partners, is the technical coordinator of the Rapid Response Mechanism, and partially in charge of the NFI supply for the mechanism. Movement restrictions adopted by the government due to the insecurity context affected access to the crisis areas with a delay in the response.

UNICEF supported with the Ministry of Humanitarian Affairs (MAH/GC) in order to respond to the consequences of the exceptional floods that affected the country: out of the 2,000 NFI kits pre-positioned in Maradi, Agadez, Zinder, Diffa, Tahoua by UNICEF, 1,000 were already been distributed by the MAH by the end of September, covering the needs of 5,460 people in Maradi and Diffa.

Lake Chad Basin crisis

Since the beginning of the year, UNICEF, through RRM implementing partners, supported 15,490 people affected by conflicts through the distribution of UNICEF NFI kits.

Mali Border crisis (Tahoua and Tillaberi regions)

Since the beginning of the year, 16,239 people affected by conflict received NFI kits provided by UNICEF in Tillaberi and Tahoua regions. Humanitarian access continues to be a major constraint, due to the security context and government restrictions mainly in the Tillaberi and Tahoua regions.

COVID-19 ADAPTATION

As technical leader of the Rapid Response Mechanism (RRM) Technical Coordination, UNICEF contributed to the finalization of the tools and protocols of the rapid response mechanism to adapt them to the COVID-19 context and to be able to continue to safely deliver the humanitarian aid respecting the “do not harm” principle. This SOP has been revised to be adapted to the evolving context: the revised version was validated during the meeting of the Strategic Group held on the 16th September.

RapidPro

In September, no reports were received for the Education sector because of the holiday school closure. 38 out of 51 health centres sent complete reports on nutrition performance. About WASH, 88 reports were received out of 249 expected water point reports and 01 alerts was received. 02 training for RapidPro focal points were held in Tillaberi.

From 23th to 24th of September, 169 WaSH focal points (29 women) were trained on the methodology of data collection and the selected indicators. On September 25th, another training was held for Child Protection focal points with the same objective. 19 focal points (05 women) benefitted from this training.

Humanitarian Cash Transfers

At the level of Niger's Multisectoral Cash Working Group, UNICEF contributed to the validation of the MEB (Minimum Expenditure Basket) tool.

As part of the emergency response, the RRM Niger was identified as an entry point for the Humanitarian Cash Transfer in Niger. The validation of an agreement in principle was made with the RRM Consortium (UNICEF, ACTED, ACF, DRC, IRC) for the start of the cash pilot project. For the moment, the activities are evolving in terms of the design of the pilot and the conception of the tools that will accompany the different stages of implementation. The project proposal for the cash pilot fully funded by UNICEF has been finalized and the implementing partner is being identified.

Humanitarian Leadership, Coordination and Strategy

UNICEF responds to chronic and acute crises in Niger. UNICEF strengthens national health and nutrition systems to deliver emergencies services, including severe acute malnutrition (SAM) prevention and treatment, measles and polio vaccination and free health care for children under 5. UNICEF, in collaboration with the UN SUN Network², also supported the Government in the preparation of a joint declaration on adequate Infant and Young Child Feeding (IYCF) in the context of COVID-19, which was submitted for signature by UNICEF and WHO country representatives, and by the Minister of Public Health. In addition, UNICEF facilitated an ad-hoc meeting of the Nutrition Sector Group to sensitize stakeholders on the International Code of marketing of breastfeeding milk substitutes in Niger.

UNICEF prioritizes access to quality school services for children affected by crises and building resilience in schools. Conflict-affected children receive comprehensive child protection services, and cholera prevention and readiness and access to safe water remain as priorities.

UNICEF leads the Education and WASH Clusters, the Child Protection Sub-Cluster and the Nutrition Technical Working Group in close collaboration with government counterparts. UNICEF technically leads the Rapid Response Mechanism (RRM), implemented jointly by ACF, ACTED, DRC, IRC, OCHA, WFP and the government, and is responsible for the NFIs procurement. UNICEF is also an active member of the MSCWG.

Human Interest Stories and External Media

Several multi-media assets have been produced and disseminated, generating discussion and feedback from audiences, while traditional media has been engaged to showcase UNICEF’s humanitarian response during the reporting period.
