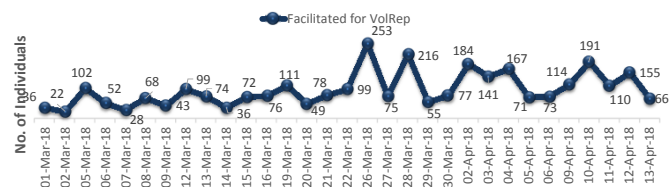

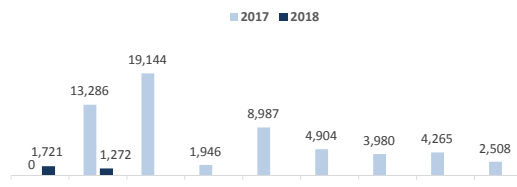

Monthly Trends Comparison

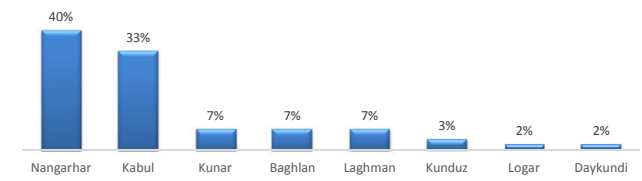


- The Voluntary Repatriation Process for the reported year started on 1 March 2018
